Please support our local businesses in Mills River as often as possible. I'm sure they would like for you to visit and see what they have to offer.


#### Citizenship Awards

#### **HISTORY CORNER**

When I was young, trails in the mountains were still quite utilitarian, but now those that remain passable serve mostly hunters, hikers, bikers, and horseback riders on recreational outings. For a few of us old timers, the restoration or periodic maintenance of an old trail satisfies a need to remember fondly a time before we owned cars when such trails provided efficient short cuts to visit relatives, attend church, or walk to the general store.


Occasionally in the Spring I devote a few hours clearing away limbs or a fallen tree along an old trail up a cove that I have owned for more than half a century at North Mills River. It actually is what one might call a "watershed cove" – drained by a spring-fed branch which flows into the river. The trail goes back at least to the mid 1930's, if not earlier. It was used to drag or haul logs, some of which provided the lumber used by my father and a neighbor to construct a house just over a ridge during 1934-35. This was the house where I lived during the years from 1935 to 1950 and is still inhabited by one of my nephews and his family. The cove trail features some very old and large specimens of mountain laurel.

The cove spring is quite a reliable source of water which has never gone dry as far as I know. There is still an old concrete box near where the water comes out of the ground which once served as a collection reservoir. I have been told that the box was once connected to a small hydraulic ram which pumped water through a long pipe to the house across the river where I was born. It provided an alternative supply of water to the old hand-dug well near the house. I don't remember the ram, but I do recall a similar one at my Grandmother Gillespie's home on South Mills River. It pumper water from a spring located a short distance east of her house. I still recall the unusual sound made by the operating ram. If it stopped for some reason, someone had to go to the spring and "prime the pump".

Several years ago I established a new connector trail which linked the cove branch trail to another old trail which I had used as a teenager and which my father had used to walk to school in the early 20<sup>th</sup> century. My connector trail joined the old trail not far from the corner of an old field where we once grew corn and near a tract of white pines planted by my father in 1940. I could still identify traces of the old trail that crossed the mountain and was able with some effort to clear it out enough to use again.

Near the top of the mountain the trail once forked with the right fork going to the site of Mountain View School near the intersection of present-day Whitaker Lane and L.L. Moore Road. For several years I used this trail fork to walk over to visit my Aunt Lola Whitaker and her family. The left fork of the old trail took one to the store and grain mill of M.A. Moore. I used this trail segment fairly frequently to travel to the store from our house to get a jug of kerosene for lamps or to purchase salt, sugar, or other staples. I have walked many other trails in our mountains, both old and new, but the trails through my Mills River land retain a special attraction to this day.





#### FROM THE OFFICE OF THE TAX COLLECTOR....

Most people don't realize that while property taxes technically become a lien on property on the first of January of the calendar year, tax rates aren't set until June (when budgets are adopted), bills aren't sent until September, and taxes can be paid without penalty until the following 5<sup>th</sup> of January (depending on when the date falls during the week). This tax year the 5<sup>th</sup> of January falls on a Saturday, so the last day to pay tax for 2012 without penalty is Monday, January 7, 2013.

If you've refinanced your property or bought property in Mills River this year, it is your responsibility (if your taxes are escrowed) to be sure that your mortgage company has our information so they can pay your tax on time. Like income tax returns, it is the citizen's responsibility to pay tax, whether or not notice is given. While we'd like to have our tax accounts accessible to the public on our website, we don't have the technology quite yet. Feel free to call Town Hall with any questions about your taxes.

If you think you might be better off spreading your tax payments out over several months, please feel free to take advantage of our payment plan. Started in July, a payment plan can spread your taxes out over 6 months and still keep you from incurring late fees and interest. Let us know if we can be of any assistance with an application.

#### RECIPE CORNER

#### Black Bean Avocado Salad

#### Ingredients

- 1 (15 ounce) can black beans, rinsed and drained
- 1 (11 ounce) can Mexicorn, drained
- 1 1/3 cups chopped peeled avocado
- 1 cup chopped seeded cucumber
- 1 cup chopped seeded tomatoes
- 1/2 cup thinly sliced green onions
- 1 small jalapeno pepper, seeded and chopped
- 1 teaspoon lime juice

#### **Dressing**

- 2 tablespoons cider vinegar
- 1 tablespoon olive oil
- 1 teaspoon ground cumin
- 1/2 teaspoon dried oregano
- 1/4 teaspoon salt
- 1/8 teaspoon pepper

#### **Directions**

In a large bowl, combine the first eight ingredients. In a small bowl, whisk the dressing ingredients. Pour over salad and toss to coat. Cover and refrigerate for at least 1 hour before serving.
